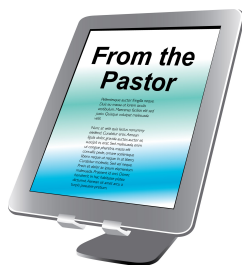

“In the Fullness of Time”

“But when the fullness of time had come, God sent his Son . . .” Galatians 4:4 (NRSV)



TIME – it always seems to be in short supply – especially during the Christmas season when there are so many special activities. We spend a lot of our time worrying about the past and what we could have done better or worrying about the future and wondering what might happen to us. Of course, we know that we can’t change the past and we can’t control the future, but we can live this day that we have been given. We can make every effort to be the best person that we can be today with the circumstances in which we find ourselves. **We can be joyful; we can pray; and we can be thankful.** We can spend the 24 hours of this day being the very best person that we can be with God’s help and guidance.

God is not like us when it comes to time. He is never worried about the past or concerned about the future, and he is never in a hurry. **He has a plan for the world and for you and me, and he is always on time.** Our theme verse above helps us understand how God thinks about time. The scriptures make it clear that God intended to send Jesus to earth from the very beginning of time, and he intended that Jesus would experience a human life with all of our limitations. This verse from Galatians states that God sent Jesus at exactly the right time. Another translation says: “When the set time had fully come. . . ” We do not know why God waited so long to send Jesus or why he didn’t wait longer. God has a whole different perspective on time. **What is clear is that God had a plan from the very beginning and for reasons known only to him, he sent Jesus at just the right time.** The passage goes on to say that he sent Jesus to redeem us and to give us the right to be adopted into God’s own family as children of God.

We celebrate the coming of Jesus during this Advent season each year. We celebrate that Jesus comes to each of us at exactly the right time. He does not come too early or too late. Just as we tell our small children that they must wait for Christmas to come, God is telling us that we must wait for him to “gather up all things, listening, trusting, transforming.” (from Day 1 in our Advent Devotional Book). These things take time and God is gracious in taking the time to forgive us and to make us into the person he wants us to be.

Come each Sunday in December and celebrate the love that Jesus brought into the world and into our lives.

A Note on Giving to Those of You Who Are Over 70

It's nearing the end of the calendar year, and I wanted to remind you that you can take advantage of the IRA qualified charitable distribution law to help manage both your charitable intent and your tax liabilities.

The law allows you to “count” charitable contributions made from your traditional IRA toward your required minimum distributions beginning the year you turn 70 ½. By directing your distribution from your IRA administrator directly to a charity, it moves without tax consequence to you or the charity. This is a very tax-efficient way to support the church and other causes you care about!

With the new tax laws in effect that greatly increase the personal deduction, more people will not be filing the long form that enabled them to deduct charitable contributions. The IRA direct distribution keeps those funds from being counted as income to you so there are no taxes due on that distribution.

More information is available from your tax advisor, attorney, or administrator of your IRA.
